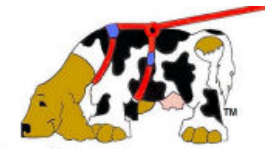

Cautionary Disclaimers - Exhibitors Please Take Note

Please note that this club does not agree to arbitrate claims as set forth on the Official AKC Entry form for this event.

The Club's Protocols are as follows: The test site is on State owned property; there is an admission fee of \$10 (non resident) and \$7 (resident) to be on the site. Permits can be purchased at ranger station near the entrance to the park. Please respect this area by cleaning up after your dog. Dogs must be on leash at all times.

General Tracking and Cautionary Disclaimers are as follows:

No dogs are to be allowed to be "off lead" – due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site.

Cancellation of Event may occur due to extreme hazardous weather conditions as determined by the Tracking Committee and Judges.

LIMITATIONS ON ENTRIES

Entries will close Wednesday September 24, 2008 at 5:00PM. The draw will be conducted at W299 S8578, Mukwanago WI at 5:30 p.m.. Entries cannot be accepted, cancelled, substituted or altered after the stated closing date and time.

Entry is limited to AKC registered dogs at least six month of age or older. If the limit for entries is not reached in the TD (or TDX) and the limit for

entries is exceeded in the other test we will exchange tracks up to the judging limit of 12 tracks.

Entries must be made on an official American Kennel Club entry form, signed by the actual owner or duly authorized agent. Conditional, unsigned, telephone and telegraph entries cannot be accepted. There will be a \$25.00 fee imposed for returned checks. All entries must be paid in full prior to showing. All TD entries must have a certification form attached.

Bitches in season may participate provided that the Test Secretary and Judges are notified that a bitch in season is present prior to the drawing for tracks. The last track shall be reserved for the bitch in season. If there is more than one bitch in season, a second draw for these bitches will be held.

Entries will be acknowledged and a judging program will be mailed as stated in the regulations. Should you have any questions please contact the Test Secretary, Penny Honetor, phonetor@wi.rr.com. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Test Committee or because it has been entered incorrectly.

No video taping of this event will be allowed without prior permission of the Test Secretary and the judges.

Directions to the test site: from interstate 39, take highway 54 east toward Waupaca. After County Highway D, look for a brown State Park sign for the Park. Turn right on Hartman Creek Road. From Park entrance, continue straight to end of the road, turn left and go to first parking lot on left.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
